SUBJECT : Expressions of Interest - A & D Tribunal

The Arbitration and Disciplinary (A & D) Tribunal is a MNSW Board appointed panel of people who are called upon when necessary to hear cases of negative conduct in our sport. The purpose of the A & D Tribunal is to hear proceedings in circumstances where a person or persons have been charged with a breach of the GCR's. The A & D Tribunal, given the evidence, will determine innocence or guilt and may apply penalties as deemed necessary.

There are a number of personal requirements that each person appointed to the A & D Tribunal must possess; a sound knowledge of the rules as outlined in the MoMS, the ability to remain impartial and the ability to keep details in the strictest confidence, to name but a few.

The Arbitration & Disciplinary Tribunal will generally convene of an evening mid week to hear proceedings. It is an unpaid position.

Motorcycling NSW are seeking expressions of interest from people who believe they have the relevant knowledge and experience to hold a place on the Arbitration and Disciplinary Tribunal. Attendance in the office is a requirement for members of any Hearing, if you are nominating from outside the Sydney basin MNSW will arrange flights and accommodation for each Tribunal that you are required to attend.

Applications open forthwith and close Friday 28th August 2009. Anyone wishing to apply for a position will need to complete the attached application, outlining why you believe you should be granted a position on the A & D Tribunal and what benefit your appointment would be to the Tribunal.

Appointment to the Arbitration & Disciplinary Tribunal is at the discretion of the MNSW Board of Directors - no discussions will be entered into if your nomination is not successful.
